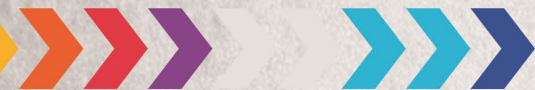

# EXHIBIT RULES & REGULATIONS

PLEASE READ THE FOLLOWING CAREFULLY AND SIGN AT THE BOTTOM

**Exhibitor** assumes responsibility and agrees to indemnify and defend the **Kumite Classic Entertainment Corp. (Also know as Show Management)** and the **Monroeville Convention Center** and their respective employees and agents against any claims or expenses arising out of the use of the exhibition premises. The Exhibitor understands that neither the **Kumite Classic** nor the **Monroeville Convention Center** maintain insurance covering the Exhibitor's property and it is the sole responsibility of the Exhibitor to obtain such insurance.

**Cancellations:**

There are no refunds for cancellations. Any exhibitor who does not follow the Expo policies and regulations will immediately have their vendor privileges revoked without a refund.

**Regulations:**

Kumite Classic Entertainment Corp. reserves the right to decline, prohibit, or deny entry to any exhibit it feels is in violation of good character and the standards set forth by the expo. The exhibitor must acknowledge that Kumite Classic Entertainment Corp. does not maintain insurance covering exhibitor's property, and that it is the sole responsibility of the Exhibitor to obtain business interruption, property damage, and other insurance covering such losses as exhibitor may incur. Exhibitors wishing to make special security arrangements may do so at their own expense. All vendors and exhibitors must maintain proper event liability insurance, and must name Kumite Classic Entertainment Corp. as co-insured, if appropriate. Exhibitor shall, at its expense and as a material part of this Agreement, obtain insurance to cover its exhibit material against damage and loss, and public liability insurance against injury to the person and property of others. The exhibit booth must be staffed by one person at all times. The expo reserves the right to modify or change the layout and floor plans. Show Management reserves the right to alter the location of the Exhibitors or booths as shown on the official floor plan, if deemed in the interest of the exposition. All vendors must adhere to the posted load-in, set-up, and load-out times. Exhibitor agrees that no display will be dismantled or goods removed during the entire run of the Show with display remaining intact until the end of the final closing hour of the last show day. The exhibitor space allotted to Exhibitor may be used only by the Exhibitor. The right to use such exhibitor space or any portion thereof may not be assigned, subcontracted, or otherwise transferred. Subletting of contracted exhibit space is NOT permitted. Special arrangements must be made in advance for two or more firms sharing the same exhibit space. Distribution of advertising material and solicitation of any products are restricted to the designated exhibit booth areas only. All vendors must abide by all local health, safety, venue, and security regulations. Exhibitors are responsible for all state income and sales taxes and are responsible for obtaining forms and filing in compliance with the appropriate State Law. Exhibitor agrees to obtain, at its own expense, any licenses or permits from government bodies which may be required for the operations of Exhibitor's trade of business during the Show .

**Violations:**

Violation of any term, rule or regulation, or refusal to comply with any interpretation or endorsement by Show Management shall entitle Show Management to revoke this exhibition license and cause the removal of this exhibit from the Complex without refund. Show Management reserves the right to restrict exhibits which because of noise, method of operation, materials, or for any reason, become objectionable in the sole judgment of Show Management and also to prohibit or to evict any exhibit which in the opinion of the management may detract from the general character of the exhibition as a whole. This reservation includes persons, objects, printed matter or anything of a character which the management determines is objectionable to the exhibition. This applies to displays, literature, advertising novelties, souvenirs, Exhibitor's conduct, etc. If a dispute arises, Exhibitor shall be liable for all costs of enforcing this agreement, including all attorney fees incurred by Show Management whether or not a suit is brought.

**Property Damage:**

If the exhibition area or any portions of the exhibition hall shall be damaged by the act, omission, default or negligence of Exhibitor, or its agents or employees, Exhibitor will pay to Show Management such sum as shall be necessary to restore the exhibition area or hall to their original condition. Exhibitor will be responsible for any damage done to the building by them, their agents, or employees. All property destroyed or damaged by Exhibitor must be returned to its original condition by the Exhibitor at the exhibitor's expense. Exhibitor shall abide by all municipal and state fire laws and regulations and shall not keep inflammable or combustible liquids or materials in or around the booth. The Exhibitor's exhibit shall comply with all city ordinances, state and federal regulations, and fire marshal instructions. All materials shall be flameproof.

# EXHIBITOR LIABILITY RELEASE

**Liability of the Exhibitor/Indemnification by Exhibitor:**

Exhibitor assumes all risks and responsibilities for accidents, injuries or damages to person or property and agrees to indemnify and hold harmless Show Management and the Facility and their managers, officers, members, sponsors, employees, agents, successors, and assigns, from any and all claims, liabilities, losses, costs and expenses (including attorney's fees) arising from or in connection with the condition, use or control of Exhibitor's display space, or arising out of Exhibitor's participation in the Show. Exhibitor shall at all times protect, indemnify, save and hold harmless Show Management, against and from any and all loss, cost, damage, liability, or expense arising from, or out of, or by reason of any accident, or other occurrence to anyone, including Exhibitor, its agents, employees, and business invitees, which arises from or out of, or by reason of, Exhibitor's acts or omissions, or occupancy and use of the exhibition area or hall or a part thereof. It is understood that all Exhibitor's property shall remain under the Exhibitor's custody at all times. At no time will Show Management be responsible for Exhibitor's property. Neither Show Management or their agents, employers, and committees will be responsible for any injury, loss, or damage that may occur to the Exhibitor's employees or property from any cause whatsoever, prior, during or subsequent to the period covered by the exhibit contract, and the Exhibitor's signing the contract expressly releases the foregoing from all such claims for such loss, damage, or injury. The Exhibitor is entirely responsible for the exhibit space allotted to it and shall be liable for any loss or damage to the premises occurring in such exhibit space and for any loss or damage to any equipment used in connection with such exhibitor space. The Exhibitor shall defend, protect, indemnify, and save harmless Show Management and the Show Facility against any and all claims, suits, actions, judgments, losses, liabilities, and expenses (including attorney's fees) relating to the Exhibitor's participation in the Show, including without limitation claims, suits, actions, judgments, losses, liabilities, and expenses arising from the injury or death of persons, or the loss of or damage to, property relating to (I) any act or omission of the Exhibitors, its employees, agents, sub-contractors, or guests in connection with the Show, (II) the Exhibitor's use of exhibitor space in the Show, or (III) any condition created by or for the Exhibitor in connection with its use of exhibitor space in the show. Show Management will not be liable for the fulfillment of this Agreement as to the delivery of space if non delivery is due to: fire, act of God, public enemy, war or insurrections, strikes, the authority of the law, postponement or cancellation of the Show, or any other cause beyond Show Management's control. Show Management will, however, in the event of not being able to deliver space for any of the foregoing reasons, reimburse Exhibitor for any amount paid, less any and all reasonable expenses incurred by Show Management for advertising, salaries, operating expenses, etc.

Exhibitor agrees to observe all agreements between Show Management and the official contractors serving the Show Facility and companies operating in the building and to observe the labor laws, ordinances, or regulations of any government or regulatory body. Exhibitor understands and agrees that this is an event that will have multiple displays and exhibits with similar products and related services.

Exhibitor agrees to hereby release **Kumite Classic Entertainment Corp.**, its agents, volunteers, show management, staff, **The Monroeville Convention Center**, and any and all other persons associated with this event in any capacity from any and all liability due to injuries, losses, or damages that I may incur as a result of my attendance and or participation at this event. I have read the rules and regulations listed above and agree to follow and uphold the standards of the expo. Furthermore, I hereby waive any compensation whatsoever for the use of pictures or video production of myself, utilized by those associated with this event, for any profit-making at anytime.
